DISCUSSION ITEMS:

8 Player Football – The committee discussed at length the growth of 8-Player Football and the effect on 11-Player teams scheduling. It was reported that there are only two UP Class D teams using the 11-Player format, while 15 other Class D schools and one Class C school participate in the 8-Player format.

The discussion also presented the possibility of dividing the more than 60 8-Player participating schools into two divisions by enrollment, maintaining a four-week tournament format and consider a maximum enrollment number that may include some smaller Class C schools.

Other concerns included the length of 8-Player contest and the notification of some officials that they will no longer work 8-Player games as some are lasting over three hours.

Given the concern for 8-Player game length, some thought that we might consider the following:

- 1. Play on a regulation field which may eliminate clock stoppage on out of bounds plays
- 2. Mandate a :40 second clock. This would add more consistency to official's game management.

Athletic Director Assistants In-service – Mr. Sean Jacques has asked the MHSAA staff to consider presenting and Athletic Assistants In-service in conjunction with the annual Athletic Directors In-service. The assistant's in-service will be held on April 27, 2017 and will include elements of ArbiterGame initiative. The Athletic Director In-service is scheduled for April 28 in Gladstone.

Basketball Officials Selection - One Upper Peninsula official was selected for the Final Round of both the Girls and Boys Tournament.

One Upper Peninsula official was selected for the Semifinal Round of both the Girls and Boys Tournament.

Five Upper Peninsula officials were selected for both the Girls and Boys Quarterfinal Round.

The committee selected officials for all Upper Peninsula Regionals and Districts. Selection Criteria:

Officials must be MHSAA registered for the current year.

Officials must have current credit for MHSAA Basketball Rules Meeting.

Officials must have the required ratings.

Note 1: In cases of extreme need MHSAA staff may waive the criteria for ratings.

Note 2: Selected officials for Quarterfinals through Finals must also have completed the required exam with a minimum score of 80%.
