8-PLAYER FOOTBALL DISCUSSION

The committee reviewed the growing interest and discussions by Upper Peninsula schools in the 8-Player Football format. The committee discussed and recommended to the MHSAA staff that the following conditions are applied when teams plan for a blended schedule of 11-Player and 8-Player games.

Blended Schedules – Teams that play 11-player and 8-player games

How will the MHSAA Tournament calculations be affected by schools playing both 8-player and the traditional 11-player blended schedule?

All 11-player games will count toward tournament points even against opponents that have opted for the 8-player tournament.

All 8-player games will count toward tournament points even against opponents that have opted for the 11-player tournament.

An 8-player game will not count toward the 11-player tournament.

An 11-player game will not count toward the 8-player tournament.

Rather:

All 8-player games will count toward the 8-player tournament for those teams that opt for the 8-player tournament.

All 11-player games will count toward the 11-player tournament for those teams that opt for the 11-player tournament.

Rationale: In order to grow 8-player football, give participating schools options for maintaining some traditional 11-player games and to afford those 11-player teams to experience the 8-player format.
