Non-Traditional Draw – The committee reviewed materials that the Representative Council will discuss relating to Non-Traditional Draws:

Council will discuss – (1) if Non-Traditional draws in MHSAA Tournaments will be determined a specific directive of the MHSAA Council and/or Upper Peninsula Athletic Committee or (2) unilateral decision of each MHSAA designated host school or (3) a decision made by mutual agreement of all schools assigned to the tournament. Or (4) allowed when, following the draw and during tournament competition, any two teams agree and have approval of both the MHSAA and the MHSAA designated host manager, and when travel distance is the concern.

# 8-Player Football Discussion

The Representative Council at its May meeting will discuss survey results relating to 8-Player Football scheduling. The survey was sent to all current Class D schools that participate in 11-Player Football as well as all schools that sponsor 8-Player Football.

The MHSAA staff developed two plans, and if either is strongly supported by schools which sponsor 8-Player programs, it <u>could</u> be implemented beginning with the 2019 and 2022 seasons.

Plan A proposes classification and geography

- Class D schools to be placed in one of two divisions based on enrollment prior to the start of the season.
- Schools in each division to be placed in one of four "scheduling sections" based on geography. Regular season schedules to be established. Each school will be required to schedule the other schools in their "scheduling section".
- A two year commitment will be required
- If schedule openings occur, these dates can be filled by cross scheduling with other sections.

Plan B is very much like Plan A except that scheduling sections would be based on geography only. Travel may be less, but ranges of enrollment would be greater.

## **Additional Discussion Items**

 Weather Related Concerns – The committee discussed the number of competition cancellations experienced this spring due to extreme weather conditions. The committee was reminded of a 2014 discussion and request to the Executive Committee requesting relief from the required four contest against MHSAA member schools. Sports with concerns are golf, tennis and track and field.

The committee request waiver to the MHSAA tournament requirement of four contest for all spring sports. 8-0 in Favor

2. Seeding Basketball District Tournament – The committee discussed the proposed seeding of the top two teams in each basketball district. There was no consensus as to the positive or negative merits of the proposal.

## **Recommendation to the MHSAA Executive Committee**

The committee request waiver of the MHSAA tournament requirement of four contest for all spring sports due to extreme weather conditions.

## **Recommendation to the MHSAA Representative Council**

The committee recommends an alternative to the discussion of non-traditional district draws for volleyball and basketball. Considering geography and the desires of member schools that make up UP districts, <u>ALL</u> Upper Peninsula districts will utilize the established non-traditional format unless ALL schools within a specific district agree to the traditional format.

This would apply to districts currently numbered as 1, 33, 65, 66, 97, 98, 99,100,101 and 102. 8-0 in Favor
