**Date:** Saturday, October 26, 2024

**Place:** Springfield Oaks County Park  
12451 Andersonville Rd, Davisburg, MI 48350

**Entry Deadline:** Saturday, October 19 at 8:00pm. You need to enter your top 10 runners into A-Net. On meet day, you will only run 7. The CPU program doesn't care which 7 bibs cross the finish line.

**Preview:** The day before the Regional (10/25) after 3:00pm will be your only time slot & day you will have to preview the course.

**Course:** A map of the course will be available on the day of the meet. It will be a measured 5,000m. course and it will be marked every half mile every 1,000m. It will be the same course used at the Holly CC Invite.

**Qualification:** If a school finishes fourth (4th) in the Regional meet with four or more runners in the top 20 places and eight (8) or more complete teams finish the race, that school will also qualify a team for the Final Meet.

Cross Country Finals qualification will include a minimum of seven individual qualifiers from each Regional race. All individuals receiving a medal (top 15) will advance. If the number of individual medalists is less than seven, then the additional qualifiers (up to seven) will be taken from the individual runners following 15th place.

**Awards:** The 1<sup>st</sup> place team will earn a trophy and 7 team medals. In addition, the top 15 individual finishers will earn a medal.

**Admission:** ADMISSION – Ticket prices for MHSAA Cross Country tournament events are \$7/person or \$10 a carload for Regional meets.

**Misc:** Be sure to arrive at the course for packet pick up, review of the course, and roster changes in “plenty of time.” Any roster changes must be in accordance with all M.H.S.A.A. rules and regulations. **All legal roster changes “*must be*” completed with our computer operator by 7:30am.**
