## 2024 Football Officials Exam for Postseason Tournament Consideration

- 1. Team A faces third and six at its own 34 yard line. A1 catches a legal forward pass and steps out of bounds at team A's 38 yard line. B2 hits A1 after the ball is dead. A1 responds by directing an obscene gesture toward B2. After the penalties are enforced, it will be:
  - a. Third and two at team A's 38 yard line.
  - b. First and 10 at team A's 38 yard line.
  - c. First and 10 at team A's 23 yard line.
  - d. Fourth and two at team A's 38 yard line.
- 2. Which of the following is true of an illegal blindside block?
  - a. It can occur inside or outside of the free-blocking zone.
  - b. It can only occur inside the free-blocking zone.
  - c. It can only occur outside the free-blocking zone.
- 3. Which of the following is an illegal free kick?
  - a. The ball is driven immediately into the ground, strikes the ground once and goes into the air in the manner of a ball kicked directly off the tee.
  - b. A kick designed to hit the ground in the open area between the forward-most players on team R's free-kick line and those in the next group.
  - c. The ball kicked into the ground to create two or three low bounces then one high, arching bounce.
- 4. Third and 12 at team K's 20 yard line. Punter K1 shanks the kick, which goes out of bounds at team K's 17 yard line.
  - a. It will be team K's ball, fourth and 15 at its own 17 yard line.
  - b. It will be team R's ball, first and 10 at team K's 17 yard line.
  - c. It will be team R's ball, first and 10 at team K's 20 yard line.
- 5. Fourth and 10 at team K's 20 yard line. K1's punt is in flight and R2 is in position to catch the kick at team K's 45 yard line. K3 is close to R2 but does not make contact. R2 must step around K3 to make the catch. R2 is downed at team K's 43 yard line.
  - a. No problem.
  - b. Kick-catching interference only if R2 gave a valid fair catch signal.
  - c. Kick-catching interference whether or not R2 gave a valid fair catch signal.
- 6. The umpire stops the game clock because A1 is bleeding. Team A requests and is granted a charged timeout. During the timeout, A1 receives medical treatment, his bleeding stops and the wound is properly covered with a legal bandage.
  - a. A1 may play the next down.
  - b. A1 may not play the next down; a team may not "buy" him back into the game with a team timeout.

- 7. Team K is attempting an onside kick. The ball is rolling seven yards from team K's free-kick line when it is touched by K1. The covering official should:

- 8. Third and five at team B's 20 yard line. B1 intercepts a forward pass at his own three yard line and his momentum carries him into his end zone. While still in the end zone, he fumbles. The ball rolls forward until it goes out of bounds at team B's five yard line.

- 9. Second and 20 at team A's 20 yard line. A1 drops back to pass. B2 holds eligible receiver A3 at team A's 35 yard line. With no receiver open, A1 is downed at his own 10 yard line. The next play will be:

- 12. Fourth and five at team B's 20 yard line. A1 fumbles at team B's 16 yard line and the ball rolls to team B's 10 yard line, where B2 bats the ball. The ball rolls out of bounds at team B's five yard line.
  - a. No foul.
  - **b.** It will be team A's ball, first and goal at team B's eight yard line.
  - c. It will be team A's ball, first and goal at team B's 10 yard line.
  - **d.** It will be team B's ball, first and 10 at its own five yard line.
  - **e.** It will be team A's ball, first and goal at team B's five yard line.

- 13. Fourth and 12 at team A's 18 yard line. K1 punts and R2 gives a valid fair catch signal at team K's 40 yard line. R2 does not touch the ball, which strikes the ground at team K's 44 yard line. At team K's 46 yard line, R2 blocks K3 in the back above the waist. R4 recovers the ball at team K's 48 yard line. The penalty for R2's foul is enforced from:
  - a. The previous spot.
  - b. Team K's 46 yard line.
  - c. Team K's 48 yard line.
- 14. Fourth and 10 at team R's 25 yard line. Team K's field goal attempt is blocked. The ball does not cross the neutral zone. K1 recovers the ball at team R's 30 yard line, advances and is downed at team R's 12 yard line. The next down will be:
