We will be using **Cranbrook-Kingswood** and **Academy of the Sacred Heart** for the tournament. Parking will be limited around the Cranbrook courts. Please refer to enclosed maps for details on Friday.

Locations and Courts:

We will be using two locations. Cranbrook will tentatively host all singles and #1 doubles on its 16 courts. #2-4 doubles will be at Academy of the Sacred Heart on 8 courts.

- Warm up courts are on a first come, first serve basis with four players per court. Please limit your warmup time to 30 minutes so as many as possible can have access.
- ***There will be no parking at the newer Cranbrook courts.*** It is suggested that players be dropped off at the courts and vehicles parked elsewhere on the campus once the upper lot is filled.
- Buses, vans and team cars will be limited to the upper lot immediately inside the crossing gate on entry. Only tournament staff, USTA officials and MHSAA officials will be allowed to park near the ice rink. (Please refer to enclosed maps for details on Friday.)

Trainers: If you are planning to bring your own trainer, please coordinate with the tournament manager.

Spectators, Qualifiers; Sportsmanship:

- Proper sportsmanship must be on display at all times. To that end, there should be no cheering when points are won by errors no matter how spectacular the preceding shot may be. There will be no noise or comment between first and second serves.
- Support your teammates but make no reference of any kind to the opponent. Spectators, regardless of connection to a team, must also exhibit the highest standards of sportsmanship described above or risk removal from the site.

Coaches allowed:

The courts are split on each side of the ice area at Cranbrook-Kingswood, therefore, on Friday, 3 coaches are allowed – 1 each for the courts at Cranbrook – Kingswood and Academy of the Sacred Heart. On Saturday, we revert to the normal 2 coaches maximum.

Officials:

- Roving officials will be watching your matches. Foot faults (especially center line foot faults) will be called. If there are issues with line calls, coaches are the only ones who may ask for an official. An official may not be available at that time due to circumstances in effect at that time.

Prohibited Items:

- Alcohol and tobacco products are not allowed in MHSAA events.
- Artificial noisemakers of any kind are not permitted.

Inclement Weather: Indoor courts are being reserved at Franklin Athletic Club in Southfield and Novi Athletic Club (formerly Sports Club of Novi). If we have to go indoors due to weather, we will restrict spectator access due to capacity limits.

Hotel and Housing:

Hotel accommodations can be found in the area.

Suggestion - Look in the communities of Southfield, Auburn Hills, Troy or Bloomfield Hills.

Finals Details:

FRIDAY, OCTOBER 18 (DAY 1)

There will be a mandatory meeting for coaches and players at 7:45 am on Friday morning at Bloomfield Hills – Academy of the Sacred Heart ([1250 Kensington Rd, Bloomfield Hills, 48304](https://www.google.com/maps/place/1250+Kensington+Rd,+Bloomfield+Hills,+MI+48304/@42.28111,-83.00111,15z)). Teams will be dismissed to their locations from that meeting.

SATURDAY, OCTOBER 19 (DAY 2)

Assuming Saturday’s play is outside for the Semifinals, Singles and Doubles matches will be played on the courts by the ice arena.

Additional Information:

- Players are responsible for following the progress of the match before theirs and come to the tournament desk to get balls as it looks like the court will open for them to take.
- At the conclusion of each match, both players/doubles teams should verify the score at the desk and return the match balls.
- You are required to call the score before starting a point. You must announce it in a clear voice and such that your opponent(s) can hear and respond if there is a disagreement before you serve the ball.
- Please keep the scoring device on court up to date. This will help all players get on court as quickly as possible.
- If there is a scoring dispute, the first question when the roving official gets to the court will be, “Has the server been calling the score?” If that has been happening, there will likely be no issues.
- Singles sticks will be in place. If a serve hits the stick and goes into the proper service box, it is a fault. A player may touch the net between the singles stick and the permanent net post without penalty. Once the point has started properly, if a ball in play hits the net between the singles stick and the net post, the point is lost and the player receiving the shot has the call responsibility.
- The PPS (point penalty system) is in effect during all play. You are also expected to conduct yourself properly at all times at the venues.
- MHSAA rules on uniforms will be enforced in all matches. Taking more than 15 minutes to remedy a uniform issue will result in a default being declared. If your hat comes off during a point, only the opponent can immediately stop the play and claim a let. If it happens again, it is a loss of point to you each time.
- Final scheduling will be posted on the MHSAA site after the draws are made. Please show each location the proper respect and pick up after yourself and your teammates.
- It is not a good idea to leave your racquets or other equipment or materials in someone’s car. You must be ready to play when the match scheduled before yours is finished.
- Toilet visits must be taken on set breaks. If it is necessary to use the toilet at other times, it will be allowed as long as the player is serving on returning to court. Toilets are available at both sets of courts at Cranbrook. Access to toilets at ASH will be determined and communicated.
