

### **2024 MHSAA GIRLS TENNIS FINALS: INFORMATION**

Dear Coaches/Singles Qualifiers:

Congratulations on advancing to the 2024 MHSAA LP Girls Tennis Finals. Here is a list of things you will need to know prior to arriving for this year's event:

- We will be using two sites, Greater Midland Tennis and Midland High School, for the first day of the tournament.
  - o If you did not have three coaches listed on your regional coaches' form, please e-mail the names of both of your coaches to <a href="mailto:ilehr@greatermidland.org">ilehr@greatermidland.org</a> and indicate which one is your head coach. This is mandatory for the creation of coaching badges that each of the coaches will need. Teams are allowed up to three coaches on Friday spread out between the two sites. For day two only, one site will be used, and two coaches will be allowed per team. Please make sure that any coach that will be utilized has completed the necessary MHSAA rules meeting.
- Coaches of teams/individual qualifiers may pick up their tournament packet between 7:00 am and 7:30 am at the Greater Midland Tennis Center on Friday, May 31<sup>st</sup>.
- Mandatory coach and player meeting is scheduled at 8:00 am on Friday, May 31<sup>st</sup> at the Greater Midland Tennis Center on court 20 (weather permitting).
  - o Important information about the tournament will be given out at this time. All players should attend this meeting before going to their sites.
- Play will begin on Friday, May 31<sup>st</sup> at the Greater Midland Tennis Center at 8:30 am.
- MHSAA rules regarding team uniforms will be enforced throughout the tournament.
- Point penalty system will be enforced. Keep in mind that code violations from the Regional Tournament carry over into the State Tournament.
